

Garden Master Pty Ltd warrant their products as they are manufactured from prime materials and will have a life of 25 years from the date of purchase before perforation by weathering in natural elements, which include natural reduction in gloss and natural colour change of the finish is not covered by warranty.

This warranty is subject to the following terms and conditions.

1. This product is installed in accordance with the manufacturer's published fixing recommendations.
2. Installation is greater than one kilometre from marine and industrial environments.
3. Installation is not near salt a water pool.
4. Sheeting installed in sheltered areas or areas unwashed by rain exposure must be regularly (on a minimum six-month basis) washed down in accordance with published recommendations (see maintenance and cleaning instructions at www.gardenmaster.net.au)
5. Wall sheeting must not be used a concrete formwork unless protected from direct contact or be immersed during construction or immersed during general exposure.
6. Perforations or damage to the sheeting caused in part or in whole by the following are specifically excluded from this warranty:
 - a) Mechanical, chemical, corrosion or other damage sustained during transport handling, storage, erection or subsequent to erection.
 - b) Attack from chemical agents, fumes, liquids (including weed killers & fertilizers) or solids other than direct rain falling not the product under warranty. Do not store fertilizer bags against wall sheets.
 - c) Areas in metallic contact with lead or copper or subject to the run-off from lead or copper flashings and pipes.
 - d) Deterioration of the sheet caused by contact with green, wet or treated timbers.
 - e) Installation subject to unusually corrosive environments at any time in the future.
 - f) Storm & tempest or other acts of God.
7. Garden Master Products extend this warranty solely to the original purchaser whose receipted invoice must be retained as proof.
8. Warranty does not include fasteners, locks, sliding door rollers.
9. Warranty terms of shed cloth (10 years), fibre glass sheets (10 years) and Hot House cover (2 years) as per the terms offered by their respective manufacturers and any claims will be passed on to the manufacturer on that basis.

Should perforation by natural weathering occurring in less than the warranty period, garden Master Products liability shall be limited exclusively to the pro-rata share of the product replacement of the affected portion as follows.

Replacement product will be supplied at a discount, which bears the same ratio to then current price as the part of the warranty period not achieved bears to the full warranty period.

Garden Master Products will only be liable for the lower of

- a) The cost replacing the product
- b) The cost of obtaining equivalent product, or
- c) The cost of having the project repaired

Garden Master Products, other nominated agent, must be given the opportunity to inspect the site prior to any remedial action being offered or taken.

Garden Master Products shall NOT be liable for.

- a) Labour costs associated with the installation or removal of affected product or fixing of replacement sheets
- b) Injury to person, or damage to property consequential losses arising from the use of the product.

Garden Master Products reserve the right to inspect prior to issuing of the warranty.

The warranty is given in lieu of all other considerations or warranty expressed or implied except to extent that any statute applicable to this contract prevents the exclusion restrictions or modification of such conditions of warranty.
